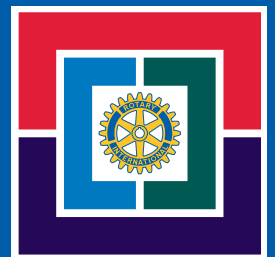

## Leaders' Guide



## INTRODUCTION

The *2009 International Assembly Leaders' Guide* has been prepared to help you facilitate the discussions on the 14 topics approved by the 2009 International Assembly Committee. The guide provides a detailed outline of the content to be covered and suggested methods of developing accompanying visual aids.

While you are encouraged to be flexible and sensitive to group dynamics during discussions, it is imperative that you cover the content outlined in each session of this guide. This will ensure that each governor-elect receives clear, standardized training and preparation based on the recommendations of the president-elect and the 2009 International Assembly Committee.

The leaders' guide provides the framework for training leaders to lead facilitated discussions, in which participants are asked to respond to questions that draw on their knowledge and experience as Rotarians. Training leaders should remain flexible, allowing group discussions to flow while using discussion questions to guide the direction and pace of the dialogue. You should be prepared to facilitate discussion. Note any critical issues that could be discussed during the Leaders' Seminar preparation.

The *2009 International Assembly Leaders' Guide* coincides with the *Governor-elect's Workbook*, which each district governor-elect receives on the first day of the International Assembly. A copy of the workbook is included in the binder the leaders' guide sessions; however, you will receive the final printed edition of the workbook at the Leaders' Seminar.

## **How to Use the Leaders' Guide**

All session guides use a standard format that includes the following components:

### **Discussion questions**

Discussion questions are sample questions that training leaders can pose to participants to encourage discussion about a key concept.

### **Sample responses**

Sample responses are examples of answers participants might give to a discussion question. Training leaders may wish to use the sample responses to encourage discussion if participants are having difficulty responding to a discussion question. Not all sample responses have to be shared with participants.

### **Key points**

Key points are concise statements that help training leaders emphasize important concepts. These points should be shared with the group. Training leaders are encouraged to restate these ideas in their own words.

### **Training leader's notes**

Training leader's notes contain information, suggestions, and directions to help training leaders facilitate sessions.

### **Refer to Workbook Page TBD**

Workbook pages refer to the *Governor-elect's Workbook*, which includes a variety of activities that are directly related to the material in the *2009 International Assembly Leaders' Guide*.

### **Daily Summary and Evaluation Session**

At the end of each day, a daily summary and evaluation session is provided. During this 15-minute session, you will have the opportunity to discuss any possible issues that were not covered during the group discussion sessions. For example, if you had questions to be addressed later, the daily summary and evaluation time allows you time to ask the governors-elect to consider those issues.

In addition, district governors-elect will be asked to fill out a daily evaluation form. The evaluation asks the governors-elect to reflect on the plenary speakers and the group discussion room sessions for the day. It is important that each governor-elect completes the daily evaluation form in order to improve future assembly programs.

- The Presidential Citation supports the organization's commitment to the RI Strategic Plan.

## How will you use the Presidential Citation to motivate clubs in your district?

### KEY POINTS

- Governors are responsible for collecting the citation forms from their Rotary, Rotaract, and Interact clubs for their files and for submitting a list to RI headquarters for the entire district.
- The list must arrive at RI headquarters by 15 April 2010.
- All certificates will be sent to governors in one mailing near the end of the Rotary year.

- It is not possible to guarantee that the certificates will arrive in time for individual district assemblies.

- *Encourage clubs to conduct assessments on membership issues, such as new classifications, diversity, identifying prospective members, club projects, etc.*
- *Communicate the importance of membership through your monthly newsletter.*
